

**HABITAT FOR HUMANITY PEI RELEASE FROM LIABILITY  
& ASSUMPTION OF RISK AGREEMENT WITH PHOTO RELEASE**

I acknowledge that I have volunteered to participate without pay on the construction site and in other activities with Habitat for Humanity Prince Edward Island Inc. (Habitat for Humanity PEI).

I am aware that construction is a HAZARDOUS ACTIVITY. I am voluntarily participating in the activities of construction, which include, but are not limited to, the construction of residential buildings, loading and unloading materials, painting, finishing, framing, transporting to and from building sites and other related activities, with the knowledge of the danger involved and with the knowledge that medical facilities may not be available in the event of illness or injury to myself. I hereby agree to accept any and all risk or injury, illness, or death and verify this statement by placing my signature below.

As consideration for being permitted by Habitat for Humanity PEI to participate in the activities and use their tools and facilities, I hereby agree that I, my assignees, heirs, distributees, guardians, and legal representatives will not make a claim against, sue, or attach the property of Habitat for Humanity Canada, Habitat for Humanity PEI, its directors, officers, agents, employees, volunteers, suppliers, contractors, or subcontractors for injury, illness, or damage resulting from my participating in Habitat for Humanity PEI activities. I hereby release Habitat for Humanity Canada and Habitat for Humanity PEI from all actions, claims, or demands that I, or my representatives, now have, or may hereafter have, for injury, death or damage resulting from my participation in Habitat for Humanity PEI activities including actions, claims, or demands resulting in whole or in part from the negligence of Habitat for Humanity PEI, or its directors, officers, agents, employees, supplies, or contractors. This release is intended to be broad in its effect.

I do hereby grant and convey to Habitat for Humanity PEI and Habitat for Humanity Canada all rights, title and interest in any and all photographic images, whether electronic or otherwise, and in any video or audio recordings made by Habitat for Humanity PEI, Habitat for Humanity Canada, or its media partners, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographic images. I further understand that Habitat for Humanity PEI or Habitat for Humanity Canada may use, or authorize use of such images and recordings for broadcasting and in fundraising and other corporate materials and I consent to such use without any royalty or payment to me.

I have carefully read this Release from Liability and Assumption of Risk Agreement and I fully understand its contents. I am aware this is a release of liability and a legal contract between myself and Habitat for Humanity PEI and that it affects my legal rights. I am signing this document of my own free will.
